This is the second time Cidco is to GVK about the fate of the project showing the growing chasm between partners. Earlier, Cidco had objected induction of investor National Investment Infrastructure Fund, Abu Investment Authority, and Investments of Canada November last year in GVK port holding company.

GVK and Cidco signed a concession agreement for the port project in January 2018. In July 2018, GVK tied up with YES Bank to raise loans of ₹3 crore but the agreement was not executed and no amount was disbursed. Now, negotiations are underway with State Bank of India for a loan.

Last July, Larsen & Toubro was awarded the engineering, procurement, and construction contract for the project, but it has not yet been given an authorization to start work.

"We have spent over ₹1 crore in pre-development. Around 97 per cent of the encroachments have been removed and around 100 families need to be shifted and an independent committee headed by retired IAS officer Subodh Kumar has been appointed to look into the details of project affected persons. Cidco official said. "GVK can start work on runwa
